# **PRIVACY POLICY**

This Privacy Policy describes how casatumu.com (the "Site" or "we") collects, uses, and discloses your Personal Information when you visit or make a purchase from the Site.

# **COLLECTING PERSONAL INFORMATION**

When you visit the Site, we collect certain information about your device, your interaction with the Site, and information necessary to process your purchases. # **DEVICE INFORMATION**

# **COOKIES**

A cookie is a small amount of information that's downloaded to your computer or device when you visit our Site.
